ARTICLE XIII of the BYC Constitution reads as follows:

Paragraph 2.

The application of each candidate for membership must be proposed and seconded in writing and signed by two Club members neither of whom shall be a member of the Board of Governors. The proposal must be completed in detail, containing the full name, address, occupation, general qualifications, etc., for membership of the candidate, and must be sent to the Secretary. In all cases the persons proposing and seconding a candidate for membership each must write a letter to the Club setting forth the personal qualifications of the applicant which letter shall accompany the written proposal, and also, they shall arrange for a personal interview of the candidate by at least two members of the Committee on Admissions. A member proposing or seconding a candidate for membership must have been a member in good standing for at least two years. No member shall propose or second more than two candidates in any one calendar year.

Paragraph 6.

All applicants elected to any category of membership shall be probationary members for a period of one year. At the end of the first year of probationary membership, each such probationary member shall either be converted to the ordinary class of membership applied for, or denied membership by authority vote of the Board of Governors. In the event of conversion to ordinary membership, the member's date of election to the Club shall be the date of election to probationary membership. In the event the Board of Governors does not elect any probationary member to the ordinary class of membership applied for the probationary membership shall cease at the end of the first year, the initiation fee shall be refunded and the probationary member shall not be eligible for membership in the Club.
